**RISK NOTICE (All participants)**

**Civil Liability Act 2002**

Sailing is a sport that involves interacting with the uncontrollable and difficult to predict elements of nature, and therefore involves a degree of risk. Many of the risks inherent in the sport are intuitive. Without seeking to list all possibilities the following are brought to your attention:

- There is a significant risk of bruises, cuts, scratches and other injuries resulting from contact with the boat or collision with other boats. Flapping sails, or unanticipated changes in wind direction or in the direction of the boat can cause a spar to bump the head or other part of the body or cause a rope flick injury. These injuries can occur both afloat or while near a boat on land.
- When launching or coming ashore, hard surfaces below the high tide line can become slippery, resulting in slip and fall injuries. Oysters and other sharp marine creatures can also grow on these surfaces. Stinging jellyfish or other marine stingers may be present in the water. Sharp objects can be hidden in sand or weed below the water which can cut or pierce feet or other parts of the body. Proximity to the elements makes it more likely for nails or splinters to be raised in wooden decks and floors and these can also cause foot injuries and trip hazards. The wet feet of sailors can make surfaces slippery.
- Because of reflected glare, sunburn will occur more rapidly than normal on unprotected skin. Dehydration or hypothermia can occur in those who do not heed and prepare for the conditions.
- Most injuries are relatively minor. However on occasions the injury can be more significant.
- When sailing dinghies on inshore waters, really serious injuries of the type that can cause permanent disablement or even death are statistically very rare but can and do occur. As with any water sport, the possibility of drowning is also present. While for many sailing activities a patrol boat might be present, the boat cannot be everywhere at once, cannot observe every incident that occurs and may not always recognise an observed incident as being a serious one requiring immediate response. First aid or medical assistance is not available.

I also acknowledge that neither The Manly Yacht Club nor any official volunteer or member shall be under any liability for any loss or damage to personal property which may be suffered or incurred by me or the minors for whom I am responsible.

**Reducing Risk**

You can help reduce risk to yourself by always following these guidelines:

- Always wear footwear while sailing or on the Club premises.
- Always wear a life vest and adequate sun protection
- Always bring drinking water along to sailing activities
- Always examine launching ramps before using them to see how slippery they are.
- Always check the weather forecast before going sailing.
- Always follow the directions of your Instructors.
- Do not run or skylark when around the Club, especially on the jetty, marinas and on launching ramps.
- Beware of flapping sails.

**CONDITIONS OF JUNIOR BOAT STORAGE**

All boats are stored at Manly Yacht Club in accordance with the following conditions:

1. Junior Boat storage is only available to Junior members participating in the MYC Juniors Program.
2. Boats are stored at the owner's risk. Manly Yacht Club accepts no responsibility for loss or damage to boats stored at the club.
3. Boats must be stored in locations as directed by the Club Captain. The Club Captain may change such locations from time to time.
4. Priority for storage will be given to those who regularly participate in MYC events. At the discretion of the Club Captain, their boats will be located in the more easily accessed positions. Boats that do not race may be asked to vacate at any time to make room for boats that do race.
5. Boats must have their owner's name and contact telephone number clearly displayed.
6. Boats must not be left unattended on the wharf or rigging deck other than in their allocated storage location.
7. Fuel must not be stored at Manly Yacht Club.
8. Boat owners must advise Manly Yacht Club of their address and contact telephone details and notify Manly Yacht Club in writing of change of address and contact telephone number.
9. Failure to comply with these conditions may cause the boat to be removed from Manly Yacht Club. Such removal shall be at the risk of the owner.
10. It is the responsibility of the boat owner to ensure that Juniors Pricing Package is paid promptly and on demand.
11. If not paid promptly and on demand the boat and any associated equipment may be sold by Manly Yacht Club and the proceeds of the sale used to meet unpaid fees. Any excess monies may be posted to the boat owner at the last notified address. Manly Yacht Club shall not be responsible to maximize the sale proceeds or for any loss occasioned by a failure of the boat owner to have notified a correct and up-to-date address.
